Summary;

On 26 Jul 10 at approx. 2300 hrs. I contacted V1 Pepka and Wit. 1 Omer to investigate their report of an attempted robbery that had just occurred in the 250 blk of 19th St.

V1 Pepka and Wit. 1 Omer told me that they were walking home together E/B on the south side of the 250 blk of 19th St. As they approached Alice St. they saw the susp. walk N/B Alice St. and turn W/B on 19th St. going towards Harrison St. They noticed that the susp. had his right hand in his R/F hoodie pocket, and as they were about to walk past each other the susp. pointed his right hand at them as if he had a concealed weapon in his pocket. The susp. said to V1 Pepka "Give me your shit! Give me your purse! Give it to me!" V1 Pepka and Wit. Omer were afraid because they knew that they were being robbed. V1 Pepka removed a small can of green colored pepper spray and sprayed the susp., who ran away E/B on 19th St., and then S/B on Alice St. marked with the green pepper spray.

V1 and Wit. 1 were not injured, and there was no loss.

I checked the area but was unable to locate the susp. I made a comm. order for other units in the area.
