## 10-Year Limited CableView Stainless Railing™ Warranty

Warranty – Subject to the terms and conditions set forth herein, The warrantor will repair or replace, at its discretion, any CableView Stainless Railing™ frame, Stainless Cable & Railing™ cable, cable assembly, and fittings used under conditions of normal use, to be free of defects in material and workmanship for 10 years. This warranty is valid for Stainless Cable & Railing™ product used in standard residential installations for the original consumer and may not be assigned or transferred.

This limited warranty is the sole warranty of the product. Stainless Cable & Railing Inc makes no other warranties other than those set forth in this warranty, except as permitted under applicable law. Stainless Cable & Railing Inc, its officers, directors, shareholders, employees, agents, and any affiliated companies shall not be liable for any incidental, consequential, special or punitive damages in connection with or arising out of the use of the product or for any other indirect damages, including without limitation, lost or anticipated revenues or profits, loss of property, personal injury, injury to reputation and/or loss of customers.

Stainless Cable & Railing Inc's sole liability with respect to defects, at Stainless Cable & Railing Inc's sole discretion, is for replacement, repair or refund, not to exceed the original cost, of the defective product. Stainless Cable & Railing Inc shall not be responsible for any other expenses resulting from a warranty claim, such as shipping, labor or other costs or expenses to remove, repair or install any defective, repaired or replaced product.

Subject to the same limitations and exclusions set forth in this limited warranty, any replacement parts used or provided by Stainless Cable & Railing Inc will be warranted for the remainder of the warranty period or ninety (90) days, whichever is longer.

### CableView Stainless Railing™ Terms, Conditions, and Limitations

1. The warrantor's sole liability and the owner's only remedy is as follows:
  - a. The warrantor will repair or replace, at its discretion the defective parts of the railing
    - i. If a problem with the cable, cable assemblies, or fittings occurs within the first year from the date of purchase, the repair or replacement will include materials, and freight costs.
    - ii. If a problem with the cable, cable assemblies, or fittings occurs after year one (1) and within year ten (10), from the date of purchase, the repair or replacement will include the material only.

2. Warranty Limitations & Exclusions: Stainless Cable & Railing Inc warrants our Product to the extent and value of the Product purchased only. This Limited Warranty does not cover and Stainless Cable & Railing Inc assumes no responsibility or, liability for damages or injury arising from, caused by or related to:
  - a. Stainless Cable & Railing Inc does not in any case accept responsibility for third party materials, labor or other cost not directly related to Stainless Cable & Railing Inc product purchased; Use of third party products such as wire rope / cable with Stainless Cable & Railing Inc product will nullify any warranty claim; or
  - b. Use, care, maintenance and handling of the Product by a party other than the Original Purchaser, including without limitation, use of the Product with any product or system not designed, produced or manufactured by Stainless Cable & Railing Inc or otherwise designated by Stainless Cable & Railing Inc in writing as being compatible with the Product; or
  - c. Failure by Original Purchaser to observe any safety or maintenance procedures or precautions in the use, care and handling of the Product; or
  - d. Any Product that has been subject to improper or incorrect maintenance or repair; or
  - e. Any Product that has been damaged by negligence, accident, mishandling, abuse, faulty installation, lack of maintenance or has otherwise been maintained, handled, or operated inconsistent with or in contradiction to the instructions and procedures described in the Stainless Cable & Railing Inc installation and maintenance instructions or in violation of the Product specifications or local building codes; or
  - f. Any Product that has been purchased or acquired from a party other than Stainless Cable & Railing Inc or its authorized dealer including but not limited to, any Product purchased from an Original Purchaser of Product; or
  - g. The ordinary wear and tear of the Product; or
  - h. Any condition of the Product caused by or resulting from weathering, scratching, discoloration, tarnishing or performance caused by exposure to corrosive elements or atmospheric contaminants such as salt spray, salt air, chemicals, and pollution; vandalism; surface oxidation; settlement, structural shrinkage, distortions or expansions of the property or structures on property on which the Product is installed, affixed or otherwise placed; fire, flood and acts of God or other causes beyond the control of Stainless Cable & Railing Inc; or
  - i. Discoloration, rust, or oxidation of the Product shall not be considered a defect covered by this Limited Warranty; or
  - j. Product claims not accompanied by proof of purchase and payment in full; or
  - k. Claims in which reasonable access has not been given to our company representative for inspection purposes.
3. The customer assumes all risk and liability associated with the construction, installation or use of this product.

4. The warrantor's only liability is for the repair or replacement of the defective part of the railing and is not responsible for the loss of use or any other consequential costs associated with the defect.
5. The word residential, as referred to in this warranty is defined as single family housing and detached duplex/triplex housing.
6. Claims must be made within thirty (30) days of the discovery of the problem. The claim must be in writing including proof of purchase and payment.
